In this video, I share my thoughts on the book by the “The Illusionist” and the author’s rush to publish it. Despite claims of honesty and promises to send out copies, the book is poorly designed with bad fonts, colors, and egotistical images on the back cover. Inside, it’s filled with name dropping and conspiracy theories. Interestingly, the publisher of “The Manson File” wrote a note about Nikolas Schreck, the editor of the first edition of the book. Schreck claimed credit for editing, but failed to deliver a camera-ready graphics by the deadline, forcing the publisher to throw together the material and write the text in the eleventh hour. The book was announced, and the publisher was not pleased to have his own name appear on this mess. Sorry, that little spiral notebook is just a book report. This is the first one. This is 1988 edition #1. From Emmett Press. And you can see it when we go through. The. Book there's pieces of things in the book I don't know who. I don't know if Manson loaned it to somebody, but there's notations and things and little. All throughout the book. Since Charlie had a pencil to sign his name, there's some things in pencil. Possibly it is. You can see as you go through the book on at any point, you can probably pause it and read the whole damn book if you want. To. But I'm not going to. I'm just going to flip through it. I'm going to give a little review of it and maybe a little review of the company book that came, you know, with him, this is this is called compulsion to nobody has this thing. It's got an interview with the 9 inch nails in it and it's also got an interview with Jonah snows. I don't know, an hour's worth of time looking for 242 publishers of French to find addition pants off the most exciting pedic brains out there. About Charles Manson couldn't find it well, happened to pop up day after I said it with an Instagram page and now they got like 40 followers. I think they've got like probably 1700 less than Stoner Van Houten does, but. Anyway, it does exist. I take it back. When I started looking for his name and then the the Shrek part of it popped up, it was Julia Shrek by the way. You can go look it up. He's the guy that's really, really close and tight with Hitler. And there's no other Shrek on the Internet. I mean, and the whole Internet I couldn't find but three shreks, Nicolas, Shrek. Julia Shrimp and Shrek. Shrek, you know, and Shrek. Shrek didn't even come around until after Nicholas Shrek had made-up his name. And then the Nicholas part of it. It's like, oh, that's got to be something Nazi, too. And there you have another Nicholas. It's really close to Hitler. And his name was Nicholas von below, and you put them two together and. Really close to Hitler and a NEO Nazi that he is that he covers for you know, he he. There's this big. Cover of how he's a satanist and some people say he's a Buddhist and some people say he's this and they'll say he's this. They'll even say he's an author sometimes, but it's just a cover for a big old damn Neo Nazis. Well, it is. This. And he's got lots of people fooled, and I really feel sorry for the people. He's got fooled because it's kind of comical watching them. But anyway, you can do whatever you like. I love my book. I I love my book and I love my Nicholas Shrek autograph, but that's about as far as. I. Go. I probably didn't get to finish what I was trying to say the other day. But I I came out and I I made a I made a statement that I think Nicholas cancelled his own Facebook page. And the reason that I said that is because I had my own Facebook group cancelled before I had a Facebook group that I started when Facebook first came, and then I mean it it had all kinds of people, everybody that you, you know that you see in this mansion thing was on at one time or another from. Star was even on it. You know, at one point. But then it got up into the Jason thing. And Jason, he got it cancel. Because people were saying things that he didn't like, so he kept reporting it. And Facebook actually told me before they canceled it that I could appeal that and they would take a look at it and they would decide whether or not that that was, you know, it should be taken down. And I never did any. I didn't care less about that group at that point. So I just let them do away with it and it took two weeks and then they got rid of it. They notified all the people that were moderators of the group that it was going

away, and then it went away and. So there's all kinds of notifications that pop up when they're canceling out here, they just can't cancel your life and not say anything about it. And and for then, for the page to come out and say, oh Zuckerberg, he's an *****. He cancelled my page. And then you come and make another Facebook page. I don't understand that much. Here's what I think happened. I think since Nicholas has been promising people to book this book for the and the world for, I don't know. The past four years, I guess at least ever since. COVID was an excuse, but I know it was before that that he was taking money for this book, probably around. Even when Manson died. And now it's gotten to the point where people are probably asking, hey, friend and family, where's my book? And he getting tired of that with all those 2000 Subs that you have on that one page. And you're a big collector of information anyway. You cut and piece stuff together in a mansion file. My mansion file is all cut and paste. It's like a scrapbook of information. So now if you've got all this information on the page and you can act like it got canceled out, all that information is yours. If you save it. So all that information that everybody put in that Facebook, everything you contributed it to it, he still got it somewhere. I guarantee that it didn't just go away into thin air or Zuckerberg's house in the closet. Some place. No, no, no. That information. He kept that information. I know he kept that information for updates or whatever articles that come along with this Manson file to try to prove that most of this fiction in it is true. Maybe, maybe not. Who knows? I was talking about the the connection between Manson Charles Manson and and and Jim Morrison, and where that whole connection came from. From Ben gurecki. And now we have quotes from Robbie in the book. Where did they come from? Did Nicholas come back to Los Angeles? Did Robbie decide? Hey, this dude ain't so bad. Let me give him a call on the telephone now. Or did they come from Ben? And Ben is not a real good, credible source either. To be making up information for a book. So this book to me, is like Alice in Wonderland to me, really, honestly. So basically let me get this straight basically. Robbie. Quoted Nick for his book. But when I was there. And I'm standing like again so close to so close to history. Man, this guy was with the doors. I love the doors, loved. I would love to say. I mean, if Ben actually knew him, for God's sakes, I was hoping he would sit down at the table and talk to us. None of that. Happened. And then when Nicholas approached him. It it it seriously

looked like Robbie was looking for security like, hey, man, I don't want in this. This is a bad vibe to me. I want out of here. I want nothing to do with the subject that this guy's coming with or I don't want nothing to do with this guy and it didn't. Yeah, he it it totally changed when he seen Nicholas. That was his. That was his whole thing about Nicholas, not anybody else in the whole club. And there was some weirdos in that club and they were all going up to him. But the minute that Nicholas went up to him with this question about this Manson ****, he wanted nothing to do with it. So I don't believe there was ever a quote. I don't even believe Ben now when he told. Me that I. I don't know what to believe to tell. You the truth. This is only my opinion. I'm not trying to convince anybody of anything. I see a lot of people on the Internet today trying to convince. Me that this book is fact. And if it's fact again back to the website that got canceled and I wasn't allowed on on Facebook, you know, it mentioned in there one time that we're going to send out copies of this book to journalists so that they can take a look at this book. Well, the only person that I see has got the book is a guy by the name of Paul. He does a show on the Internet on YouTube called podcast. He's a journalist. Since when I thought this **** was going out to like Oprah, you know? And and Paul's got it and and then Paul's sitting there like, I don't know how I got this. I can tell you how because you're the only one that believes in my guess, because otherwise. It would have been out to real journalists and if he would have sent a spiral notebook copy of his book to a real journalist, they would have thrown it in the trash. They would have thrown it in the trash. So that's the reason that you've got the book and no other journalist has the book. And then there was an interview the other day with Nicholas. It's like the interview done about the book. No, let's get that straight. It wasn't the interview done about the book. It was the interview that was done with Nicholas Streck. That wasn't good enough for any kind of broadcast. So they threw it in the trash, basically. But, well, Nicholas was doing his own interview. He screenshot himself. So that he could make it look like, wow, look, I'm doing book interviews here with, with and he calls him. He calls him an armchair expert. That guy's a *****. That guy's a complete freaking *****. Armchair expert. What's he know about Charles Manson? Everything. If Nick's talking to him, he's an expert. Now he's the armchair expert because he's talking to Me.

Nah, he ain't no expert. You don't know **** about Manson and the stuff that they filmed. Nobody cares less about it cause they threw it in the trash. And when? When David says in that interview I have another interview next that was me. And after I found out Nicholas was. Nicholas was part of this stuff. I never even did it. David sent me the microphone. He sent me all kind. I'm keeping all that and I ain't doing the interview. And they canceled the whole thing. So that's the interview. And Stoner was on there. Laugh at the things that I see on the Internet about Charles Manson in this

book. But anyway, I'm talking too much. OK, the. Oh, in the in the. As a matter of fact, I watched that interview because again, I watch everything Manson. It's hard for me to watch things Nicholas, though, because he makes up so many. But I I watched. I watched the interview, the interview that was canceled, the one that they took out of the trash. And in it, the very first thing in it, Nicholas says, how he meets Manson Manson. He first thing he does is he connects Henry Rollins. Henry Rollins wanted to make some of Charles mean. That's a lie. That's a lie. Because Nicholas didn't even meet Charles Manson until he did that. The film that he was in with Charles Manson. Like like I was talking to Stoner about in the live interview. If you didn't get. To see it. I when I went into the visiting room and talked and sat and sat for long periods of time for many days with Charles Manson, I would ask him all kinds of questions and one of the questions that I did ask him well, you know, you try to. You try to be. Like a name dropper, like Nick is, you know? And so I went in the visiting room acting like, oh, cool. Like, I knew a bunch of people, you know, I knew about a bunch of people in Charles Manson's life. But actually, these people ain't in Charles Manson's life when you're talking to Charles. Hanson. Because when I brought up Nicholas Street's name, he was like, I don't. I don't even know who you're talking about. And then you have to explain to him, like, hey, you did this, you did this. He was he was like, interviewing you for this thing, you know. And it turned into a video and man sits in prison. He don't get the video. He don't know. All he knows is. People come in, they interview him and they promise him they all of them, usually promise him in the world. They always tell him they're going to send him money or they're going to bring a guitar in so that he can play or they're going to send him a guitar afterwards. Or they're going to send him pictures of the interview and none of them ever do it. They just promise him to get him. They get him, and then they stick. Him. And so Nicholas was just one of these people. He was a guy that. Promised him the. World. Because he wanted an interview with him and. Ohh man. Sounds like I'm just cutting on neck. I'm really not cutting on neck. This is actually it's a book review. I guess. If if I'd have anything nice to say about the book though, the guy has excellent grammar. He has a command of words like no other. I mean he must have, like, 4000 discourses in his house. He has a good command of the English language. He uses big words to fool stupid people. Everybody that's watching me right now on this video and wanting to be in some kind of a connection with Charles Manson and a book where you can write a book about yourself one day and say, hey, man, I was 3° away from Charles Manson. You are right now just listening to me talk about Charles Manson. The guy that I knew. You are three degrees away. So that next you should be on strikes. Next book. Really to tell you the truth, because you're closer than some of these people that he uses as unnamed sources. Another thing that when it comes to Manson, you just have to believe people want to tell you. Especially like for example myself. If I tell you something, you're probably going to believe me more than you're going to believe somebody that doesn't know Charlie Manson at all. So of course Nick knows Manson. I'm not taking away from the fact that. Nick, don't. Nick don't know Manson because on the one occasion when he went there and he did the video and he was Geraldo. You knew him then and then back in about it was around 2000 when he was promoting the first, you know, just put out his other book about man. Star and Gray Wolf were like in charge of manse, and then they were losing control. Gray Wolf was dressing in like a he was dressing in like a priest costume and and star was in a nun outfit and they were sitting and hugging trees and things. People, they were just lost control. And to make it look like they had a little bit more control and they were in. And they were more in touch. They had the here come stand with us. Nicholas, make us look more credible. And he went back and visited Manson one time, then. So when he was in the visiting room doing the Heraldo thing. If he got some great information, why didn't he put it on the video? If he's like, yeah, I went back to the Tate house then which that information. That's another thing that didn't come from him either. Manson didn't tell him that. Believe John Wayne's son over some, you know, fan of John Wayne. That's all I was trying to say. So when nick? Says that. Manson told him this information like he told it to him. Either he told it to him sitting there talking to him, so when he was Geraldo, did he tell him that information then? Because when he was Geraldo, he was in there as the camera guy and the interviewer guy. And hey,

Charlie, I'm Geraldo. Did he tell him that information then? Because if he did, why didn't Nick? Put it on film. You know, why didn't he like? Why Manson saying I went back to the Tate house? He don't know where on film. And if he told it to him on the cell phone where Manson would call him in the middle of the night on the. Cell phone. Hey, Nick, it's me again. Remember Me? You know, when the hell did that ever happen? First off, let me explain the whole thing about the Manson and the cell phone thing. Because people, people make Manson sound like he's Superman at times, and Manson was the most hillbilly backwards ***** I ever met in my life. He couldn't operate. Can you operate a cell phone? Can your mother? Operate a cell phone. What about your grandmother? Can she operate a cell phone? Because people make Manson sound like that. He is a genius with a cell phone. I can tell you this. At one point, Manson he he wanted, he wanted. He wanted something so he could record himself. He wanted to sing. He wanted to sit and sing and record himself and put out more albums with it. Well, he got a recording device. He couldn't even figure out how to use it, and it basically had play. Stop, Fast forward and they couldn't figure out how to use it. He and he flushed it down the toilet. It's like, hey, Manson, did you do anything on that recording thing? It's like, well, I couldn't figure it out. I flushed it down the toilet. But now you're telling. Me. He can use his cell phone. And he calls you in the middle of the. Right to tell you information about 50 years ago that he really doesn't care about talking about it anyway and and he's going to call you Nick in Germany. So that means he had to get himself a little device to put in his cell phone to call to Germany in the 1st place, cause there's a lot of numbers there. There's about 5000 numbers called Germany and Manson. Can't even hardly get 10 numbers, right, you know, and you got all these numbers in Germany. And I got the SIM card and I got the phone stored under my bed and I'm going to call Nick in the middle of the night in Germany and tell him about things that happened at the at the Tate House back in 1969. Common sense says that ain't true. And another thing that says that isn't true is half the cell phones. How did they even get into Corcoran? Did you mail it to him? He's. Like hey here, here's. A package Nick sent me a phone. Wow, I better call him about the tape stuff. How did Manson even get the phones? I can tell you that too, because I know how he got the phones. And I'm not saying I gave them to. I didn't. Manson got the phones like this. Manson is a First off. You gotta remember where Manson is. He's in the middle of of of PHU unit. And what the people that keep in that pH unit are they're people they're still some of them are still on. Trial. Some of them have are going into the witness protection. Program so they come in as James and they go out as Jimmy or they go out as even Ralph, you know, and you don't know who they are. They can come in as a criminal and they come out as a guy with a family. That's the kind of unit that Manson lived in. He lived. In a place where they have. Despicable ***** in there all the time. There's turning states, evidence on other despicable ***** and these people go there so that tells you they're already liars. They're already gone, man. They're already and that and. They. The government promises them if they give up this evidence on these other,

bigger people that they'll change their identity and they'll let. Them go out the back door. So some of these people are still on trial, and when you're on trial, you can have attorneys come in and attorneys can bring everything. They don't check attorneys, so the attorneys can just walk right in with a briefcase and all kinds of. Thanks and all these cell phones that you hear about Manson have and every one of them came into that place either through a guard who was scared of an inmate in there and the and and got threatened by him. And it's like either you bring his phone in or I'm going to kick your ***. So a guard will do it. Or one of these attorneys that's working on a case with one of these other scumbags that's on a witness. The Texan program had it out the back door and they handed them the phone, which is really illegal. I mean, I mean, so if so not to get caught. So basically this scumbag attorney comes in. The phone and he gives it to another scumbag who's turning who's who's basically lying on not lying, but telling everything that he did criminally with this other guy so he can get himself out of trouble. This attorney does not want this phone. To be caught. With this guy by the guards, because if he gets caught with the phone. They realized the only way you could have got the phones from the attorney. So these dudes, they give their phones to man. Listen. And Charlie says, hey, let me look at it. So I took it. And I slid it like a over to him. Quickly look at it. And then he did the same. Thing, put his. Turned it

around and slid it back, and then when he did that and I had it in front of me again, looking at it, he says, you know, you made a deal with the devil, right? Meaning that. If I showed this picture to people at work, I might get fired if I showed it to people at church, I might get kicked. Out of church. If I showed it to anybody, there might be some repercussions that come with that. I knew what he meant. I didn't make no deal with the devil, but basically I did. If I show this picture to some. Right. Well, right at that moment, after he said that, I went. How do you know you didn't make a deal with the devil? Because I can say anything I want to say about you now. How do you know you didn't make a deal with the devil? That's what I told him. Because I can say anything I want about. Charles Manson now and people are going to believe it because they believe everything anyway. Because Charles Manson's Dracula. So he made more of a deal with the devil by getting in a picture with anybody he ever got in a picture with than they ever made a deal with the devil of getting in the picture with him. And. Manson made a damn deal with the devil when he got in a picture with Nicholas Shrek. And he made a damn deal with the devil when he got in the. Picture. With. Ben. Oh wait. He never got in the picture with Ben because they were never in the same damn room. They were barely in the same damn state together, let alone same room.

So, everything here take it with a grain of salt, unless you can get some kind. Of proof. That somebody actually did make a deal with the devil. And when they did. You'd better find out who the devil is. So just like I told Michael Bruner about. What they said and what Charlie said. What Charlie told me. About him and Dracula. At one point Dracula was a real person. In Transylvania, who maybe had some creepy ways about it, did some weird things in life. And then before you know. It. He's a guy that's a bat. You can only kill him with a wooden stake. He lives in a casket and he sleeps all day long and then he searches for blood all night. That's Charlie Manson. That's Charlie Manson. Now one day, Charlie said. I'm going to turn into Dracula. And he was right. That's the way after I told his son about this story, he gave me that holder. Because he knows it's true too.

One day. His dad's gonna be Dracula.
