Do not enclose cash, personal checks, letters, pictures or any other items in the envelope. Enclose only the allowable negotiable instrument. The national LockBox will forward any items enclosed with the negotiable instrument to the inmate. Personal in nature, must be mailed directly to the Federal Bureau of Prisons' institution where the inmate is housed. Name and return address must appear on the upper left hand corner of the envelope to ensure that your funds can be returned to you in the event that they can not be returned to the inmate's account.

Dear Brian,

Thanks for your letters postmarked 2/18/14 and 2/26/14, and for your letter dated and postmarked 4/11/14. To answer your questions:

- No, I don't believe everything in life is just a set of numbers.
- To judge from the very little I've heard about I would say that the "chem trails" stuff is just another hooky conspiracy theory.
- I'm not going to check your daughter's "PreCalc" in detail, because I've forgotten most of those trigonometric identities years ago, but it looks to me as if her teacher is right. Just to take one example, on problem 4 your daughter wrote " $1 - \cos x = \sin x$ ", which is dead wrong. Actually, $1 - \cos^2 x = \sin^2 x$, which is something quite different. To your daughter I offer the following advice: (1) Make sure you have all your trigonometric identities memorized accurately. (2) Keep your work neat and well organized. No matter how bright you are, you can ~~to~~ do well in advanced math if you can't organize your work neatly.

Dear Brian,

Thanks for your letter of 7/22/14, which I received on 7/30/14. I'm sorry to hear that your back problem forced you to quit your job at the ice house, but it's good that your daughters are working and helping to pay the bills. You complain about your son being addicted to video games. I've heard the same complaint from another guy about his son-- and meanwhile his daughter is doing fine. I've had some people helping me with my new book-- doing research for it and so forth-- and the best ones, by far, are the women. They are the ones who do most of the work. The men haven't been worth much. It seems as if females hold up better than males do under modern living-conditions. Males are getting screwed up worse than females are, and widespread addiction to video games is only one symptom of it. I haven't seen any relevant statistics, but my guess is that the statistics would show that far more males than females are addicted to video games.

To answer your questions: You ask, "What name do you go by?" You can call me "Ted." Did I like being a professor? No. Do I have a TV? Yes, but I refuse to watch it, except occasionally the news channels, a little bit, when something big is happening in the news, and the institutional bulletin channel, which gives the time and serves as a bulletin board where they post information about things that are going on in the prison. But the TV also serves as a radio, and I listen to the classical-music station. Do I have children? No.

You ask what it was like to go to Harvard at the age of 16. Well, I didn't fit in with those people socially, but academically it was a powerful experience. When I was in
